A RESOLUTION ESTABLISHING

PAVILION RENTAL/RESERVATION FEES FOR

ARGOS COMMUNITY PARKS & RECREATION'S PROPERTIES

Section 1 Be it resolved by the Park & Recreation Board of the Town of Argos that the following fee schedule was established for pavilion rental/reservation at Argos Community Park, Memorial Park, Foker Park and Nickle Plate Square.

Section 3 That payment of above fee is to rent/reserve that particular pavilion/unit for a particular day which will guarantee use of said pavilion/unit on the date requested providing the requested has not already been rented/reserved. There is a 50% cancellation fee for all cancelled reservations.

Section 4 There will be a \$250 refundable deposit for the Depot Building and a \$75 nonrefundable cleaning fee for same building due at time of reservation. Once the rental dates have passed and no damage is found the deposit will be refunded by the Clerk Treasurer. Total amount due at reservation of depot building is \$458.75. There is a \$50 alcohol permit fee for Depot building. Must have security if serving alcohol on Nickle Plate Square property. Must provide proof of alcohol permit if required by state law. Rental/event on property can't go past midnight. No additional chairs or tables will be provided by Park. Tables currently in the depot are not moved without prior approval.

Section 5 The payment for the reservation will be made at the Clerk Treasurers Office when reservation is made.

Section 6 This Resolution shall become effective on the 16th day of February 2023 and remain in full force and effect from this date forward unless rescinded or amended by resolution.

Section 7 Failure to return any key issues will result in a \$100.00 replacement key charge.
