Attorney Jones then asked the Council if they knew when the survey on the property given to the MCEDC for the construction of the manufacturing center would be done so that the Town could reclaim all, but the 14 acres donated to the MCEDC. The farm lease that the Town does every year is due to be advertised and it is about a 45-day process. Mark Umbaugh from the MCEDC stated he would look into that and report back to the Council.
