<u>Remount of Ambulance</u> – The remounted ambulance should be completed around November 25<sup>th</sup>. The Town of Argos as the provider unit has applied for a loan through the Indiana Bond Bank in the amount of \$160,000.00. After discussion Vice President Wenino stated a meeting with all the board members from Green and Walnut Township, as well as the Argos Town Council should be held, they have any funds that might help reduce the cost and pay off the ambulance faster. Clerk-Treasurer Mullaney will try to set up a meeting in the next couple of weeks.

Chief Dean stated the old chassis will be picked up this week. After a discussion Vice President Wenino motioned to allow the sale of the old chassis. President Snead seconded; motion carried unanimously.

## Chief's Update:

Chief Dean presented his written report. Six volunteer firemen just passed Fire Protection 1 &2 class. All trucks passed the pump tests with one tanker having a small leak on a valve. Chief Dean then asked for \$3,800.00 for a new 800 radio for the remounted ambulance. After a discussion Vice President Wenino motioned to allow the purchase and installation for the remounted ambulance. President Snead seconded; motion carried unanimously.

Chief Dean also asked for cameras to be installed on the outside of the station to catch movement on the apron and side door of the station. After a long discussion, the board members would like to see the two new cameras installed and access added to the main lounge room for the on duty EMT.
