Two of the bids listed the additional work in an addendum that was emailed and required as part of the bid. After review and discussion, Member Byers motioned to award the project to E & B Paving and Construction for \$1,042,920.00. Even though the extra work was not in the bid as an addendum, the work was included in the bid, and did not affect the amount of the bid. This motion would also give the President of the Town Council authority to sign to accept the bid for CCMG 2024-2. Member Snead seconded; motion carried unanimously.
