## Old Business

### Attorney Report:

Attorney Jones stated that he continues to work on pending town legal matters, including contract reviews and ongoing compliance issues. No new actions were required at this time.

- **Second:** Vice President Partin.
- **Decision:** Motion carried unanimously.

**Other New Business:**

- **Second:** Vice President Byers.
- **Decision:** Motion carried unanimously
